



Mr. IENG Sary, through his Co-Lawyers (“the Defence”), hereby submits his list of proposed experts¹ and notifies the Trial Chamber that he does not intend to call any witnesses or Civil Parties at this time and thus will not be providing the Trial Chamber with these lists as required by its Order to File Materials in Preparation for Trial.² Should the OCP be granted leave to request additional witnesses throughout the trial, as it has requested,³ the Defence submits that it must equally be afforded the opportunity to call any witnesses it deems necessary to Mr. IENG Sary’s defence as the trial progresses. Should need arise at any point during the trial to call any witnesses, the Defence will seek leave to do so and will provide the requisite reasoning as to why it would be in the interest of justice to hear the witness(es).
