SON ARUN: 3 Mr. Saut Toeung, I am counsel for Nuon Chea and I have just a few questions, four questions in total, and I will be putting the 4 5 questions in 15 minutes. 6 [09.08.44] 7 Q. How long had you been working closely with Nuon Chea? MR. SAUT TOEUNG: 8 9 A. I had been working with him since 1975 through '77 and 1978, but I don't remember the details. 10 11 Q. Through my observation and having reviewed your biography, you 12 appear to have known Mr. Nuon Chea very well. 13 Can you tell the Court whether Nuon Chea is a cruel person or he 14 is a person who wishes to educate people to be good? 15 A. When he was in power, he was a good person. He provided good 16 education to us. I don't know other things, other -- other than 17 that. 18 Q. You had been close to him almost every time. Had you ever 19 heard from any other people that Nuon Chea had sent people to 20 S-21, sending them to Duch, for example? 21 A. I have never heard any of this. 22 [09.10.44]23 Q. Yesterday, both the prosecutors, the Lead Co-Lawyers for the 24 civil parties, and my co-counsel put some questions to you

I was just waiting for the French 12 translation, which came at the same time as the witness' answer, 13 but I would like to lodge an objection with this question, which 14 is, as it seems to me, something that is highly suggestive and is 15 guiding the witness towards a certain objective, and I don't 16 think that kind of question should be asked.

18 but I'm sure that's not the fault of the interpreters. Thank you.

This is not different when it comes to the oath taken by people who are the followers of other religions, because this oath would be read out by a court greffier and that the procedures of the oath taking would be read out or explained to witness before the procedure takes place. [09.17.24] You may proceed to another question. And you should refrain from digging into this topic again. BY MR. SON ARUN: Thank you, Mr. President. Q. Mr. Toeung, I would like to proceed to the second question. Yesterday, you said, when addressing the questions from the Prosecution and the civil parties' counsels -- you indicated that sometimes you got letters from Nuon Chea to Duch; it was on three occasions. Sometimes you responded that four to five times; sometimes you said you did not get any letters from Nuon Chea to Duch. So, to be clear, could you please tell the Court whether you got any letters from Nuon Chea to Duch? Yes or no? MR. PRESIDENT: International Co-Prosecutor, you may now proceed.

It was impossible to see anything inside as we were blocked by 10 the concrete wall. 11 Q. How tall were the walls of K-1 and K-3 buildings? A. It -- the wall was about 3 metres tall. 12 13 [09.30.42] 14 Q. Could you see any aspect of the situation inside the two premises from the outside? 15 16 A. I said I did not see anything because it was concealed by the 17 wall. 18 Q. Thank you. 19 Had you ever attended any meetings conducted at K-1 or K-3? 20 A. No, I hadn't. 21 Q. In the meeting room, did you know what was going on - for 22 instance, the meeting between certain leaders inside? 23 A. I did not know. 24 Q. Did you know what the meeting was all about? 25 A. I was never told; it was their business.
